As an enrollee under the School of Choice program, 10th – 12th grade students are not eligible to Participate in competitive athletics for one full semester after their date of enrollment. First time 9th Graders establish their eligibility when they enter the 9th grade. This is a Michigan High School Athletic Association regulation.

As an enrollee under the Schools of Choice program, 9th – 12th grade students’ schedules will be determined by meeting with a counselor and having a schedule developed from the specific courses and number of sections available at the time of registration. River Rouge Schools will be under no obligation to create and/or add additional courses or sections. At the K – 8th grade level, students will be assigned to the building specified for their grade.

As an enrollee under the School of Choice program, class designation in grades 9th – 12th will be determined based on the number of credits the student has at the time of enrolling in the River Rouge Schools compared to River Rouge High School’s actual number of credits designated for each grade level. There will be no tuition or other enrollment costs associated with attending the River Rouge Schools. Schools of Choice students will be expected to pay any or all costs that are paid by resident students of the River Rouge School District, with particular attention to the district’s Codes of Conduct and Dress Codes. School of Choice students will also be expected to adhere to all the rules and regulations of the Schools of Choice Legislation.

As the parent/guardian of the applicant or as the applicant in the event he/she is 18 years of age, I, the undersigned, hereby understand and agree to abide by the information set forth in this application and agree that any false or incomplete information provided may disqualify my application for a Schools of Choice position or may cause my child to be exited from the River Rouge Schools. I also agree, in the event I am enrolled in the River Rouge School District, to abide by the rules, regulations, and policies of the River Rouge School District as well as the rules and regulations set forth in the Schools of Choice legislation and as issued by the Michigan Department of Education from time to time.
