A pre-bid meeting and walk-thru for all prime mechanical contractors will be held Tuesday, November 5th, 2024 at 2:00 pm at the Dunn STEM Academy.

Project Scope of Work:

Base Bid

- Remove and replace 31 existing 2 pipe heating only unit ventilators with new 4 pipe heating and cooling unit ventilators.
- Install a new 125 ton packaged chiller and accessories.
- Install new chilled water piping throughout building to the new unit ventilators.
- Remove and replace one packaged rooftop HVAC units.
- Install two four pipe fan coils.
- Install a new DDC Building Management system.
- Remove and replace existing 1st floor corridor and classroom ceilings and lighting to route new chilled water mains.
- Air and water test and balance.

Deduct Alternate #1 - Temperature Controls

- 1. Delete all work associated with installing a new central building management system.
- 2. All new equipment shall be provided with stand-alone factory controls.
- Utilize wired thermostats which shall be provided by unit vent manufacturer in lieu of controls being provided by temperature control contractor. All wiring for stand-alone controls shall be installed by mechanical contractor. Thermostats shall be wired by mechanical contractor. Utilize wire molding to route new wiring down wall to unit vent and thermostat.

Deduct/Add Alternate #2 - Piping

- 1. Base bid pricing shall be based around using polyethylene piping for the new chilled water piping.
- 2. Alternate pricing shall be provided for using copper and steel piping for the new chilled water piping.

Proposal Requirements:

Sealed bid proposals are to be accompanied by a bid bond from an authorized surety company or certified check in the amount of 5% of the bid proposal submitted.

The accepted bidder will be required to furnish a performance bond and labor and material bond, each in 100% of the contract.

Submit copies of license and insurance with your proposal.

Project Start Date: ASAP.

Substantial Completion Date: August, 2025.
